### MEd in School Counseling Program Alternative Criteria

The School Counseling program faculty requires the following criteria to be used as an alternative to criteria (a), (b), or (c) in Policy 2160.3 for evaluating nominees for Associate Graduate Faculty membership in teaching.

Associate Graduate Faculty membership may be granted to nominees who meet all of the following criteria:

- a. Completion of a master's degree in counseling with a specialization in School Counseling from an accredited program
- b. Hold a current school counseling license with a minimum of 6 years of professional experience working as a counselor in the K-12 setting
- c. Membership in professional associations relevant to school counseling
- d. Completion of professional activities that include professional or scholarly conference presentations and/or speaking engagements pertaining to counseling, education or mental health topics within the past 5 years and provide evidence of a broad-based publication (i.e., district/school newsletter, newspaper column, editorial, professional association article, etc. in the past 5 years.

An Associate Graduate Faculty membership requires a nominee's CV, transcript, copy of professional license and evidence of one professional activity.

# MRC in Clinical Rehabilitation Counseling Program Alternative Criteria

The Clinical Rehabilitation Counseling program faculty requires the following criteria to be used as an alternative to criteria (a), (b), or (c) in Policy 2160.3 for evaluating nominees for Associate Graduate Faculty membership in teaching.

Associate Graduate Faculty membership may be granted to nominees who meet all of the following criteria:

- a. Completion of a master's degree in counseling with a specialization in Clinical Rehabilitation Counseling from an accredited program
- b. Be certified as a Clinical Rehabilitation Counselor (CRC) with a minimum of 6 years of professional experience working
- c. Membership in professional associations relevant to rehabilitation professionals
- d. Completion of professional activities that include professional or scholarly conference presentations and/or speaking engagements pertaining to counseling, education or mental health topics within the past 5 years and provide evidence of a broad-based publication (i.e., district/school newsletter, newspaper column, editorial, professional association article, etc.) in the past 5 years.

An Associate Graduate Faculty membership requires a nominee's CV, transcript, copy of professional license and evidence of one professional activity.

#### MRC in Addictions Counseling Program Alternative Criteria

The Addictions Counseling program faculty requires the following criteria to be used as an alternative to criteria (a), (b), or (c) in Policy 2160.3 for evaluating nominees for Associate Graduate Faculty membership in teaching.

Associate Graduate Faculty membership may be granted to nominees who meet all of the following criteria:

- a. Completion of a master's degree in counseling with a specialization in Clinical Mental Health, Chemical Dependency or Addictions Counseling from an accredited program
- b. Hold a current license as an LPCC-s or LICDC-s in the state of Ohio with a minimum of 6 years of professional experience working with clients with addiction issues.
- c. Membership in professional associations relevant to counseling
- d. Completion of professional activities that include professional or scholarly conference presentations and/or speaking engagements pertaining to counseling, education or mental health topics within the past 5 years and provide evidence of a broad-based publication (i.e., district/school newsletter, newspaper column, editorial, professional association article, etc.) in the past 5 years.

# MS in Clinical Mental Health Counseling Program Alternative Criteria

- b. Hold a current license as an LPCC-s in the state of Ohio with a minimum of 6 years of professional experience as a counselor.
- c. Membership in professional associations relevant to counseling
- d. Completion of professional activities that include professional or scholarly conference presentations and/or speaking engagements pertaining to counseling, education or mental health topics within the past 5 years and provide evidence of a broad-based publication (i.e., district/school newsletter, newspaper column, editorial, professional association article, etc. in the past 5 years).
